PREFACE

Jamaica conducted its Fourteenth Census of Population and Housing in 2011. Under the provisions of the Statistics Act, the Statistical Institute of Jamaica (STATIN) is vested with the authority to conduct any census in Jamaica. The census plays an essential role in all elements of the national statistical system, including the economic and social components. Census statistics are used as benchmarks for statistical compilation or as a sampling frame for household sample surveys. The national statistical system of almost every country relies on sample surveys for efficient and reliable data collection. Without the sampling frame derived from the population and housing census, the national statistical system would face difficulties in providing current reliable official statistics.

While recognizing the importance of the census however, countries are faced with serious resource constraints. Census taking in Jamaica faces not only the challenge of limited resources but an apathetic public which views official data collection with suspicion and even hostility. Despite a vibrant publicity programme for Census 2011, the level of cooperation particularly in some urban centres was disappointing. Worker attitude also presented problems as in a number of cases workers had to be relieved of their duties due to poor and or unproductive work. There was not always sufficient recognition of the fact that remuneration was for work done.

The processing of the census returns is a massive undertaking for which STATIN sought to utilize modern technology for this phase. The data processing of the questionnaires was out-sourced to XSOMO International Ltd., who was required to produce the electronic data in a database format and images of the questionnaires. Scanning of the forms which began in June 2011 ended on January 31, 2012. The data editing and cleaning were done using software developed internally and shared via the intranet. The validity and consistency checks which follow will continue until a full and clean database is produced. As the process continues, reports on those topics for which checks are completed, will be produced. At a later date, The Statistical Institute will entertain requests for unpublished data according to stipulated procedures and conditions.

This report is one in the series of subject reports which will provide tabulations based on the specific topics covered on the census questionnaire, at varying geographic levels. This report presents tabulations on the Economic Activity Status of the population. Tabulations are presented at the parish level.

Among the reports to be published is a separate report for each parish which brings together tables on all topics in one volume.

BACKGROUND TO THE CENSUS

Legal Authority for the Census

The 2011 Population and Housing Census was taken under the provisions of the Statistics (Amendment) Act 1984. In accordance with Section 4 of the Statistics Act, the House of Representatives approved the Census Order, 2011 on January 5, 2011. This Order authorized the taking of a Population and Housing Census in Jamaica between April 5 and December 31, 2011. Also, under Section 6 of the Act, the Minister of Finance and Planning made the Census Regulations, 2011 on January 5, 2011. These Regulations outlined the conditions under which the census was to be conducted.

Coverage, Design and Methodology

Censuses of population are generally conducted on either a 'de facto' or 'de jure' basis. A 'de facto' census seeks to determine the number and characteristics of the population present in an area at the time of the census. The 'de jure' census identifies the population usually resident in the area whether physically present or not, at the time of the census. The 2011 census, like all since 1943, was conducted on a 'de jure' basis. The 'de jure' count includes all persons, Jamaicans and non-Jamaicans whose usual place of residence was in Jamaica even if they were temporarily (less than six months) abroad at the time of the census.

The following groups were excluded:

- (i) All Jamaicans (including diplomatic personnel) who were away from the country for six months or more;
- (ii) All visitors to Jamaica who are usual residents of other countries; and
- (iii) All foreign diplomatic personnel located in Jamaica.

One questionnaire was developed for use in the census to collect information from households (Appendix II - Form PC011A) and one for individuals (Appendix III - Form PC011B). The data collecting method utilised was the "Interviewer Method". One census taker was assigned to each enumeration district (the smallest census geographic area) to list every building in the area assigned. Where the building was found to be the living quarters of an individual or a group of individuals the form was completed for each household and each person. Each census taker worked with a household form and an individual form. Consideration was also given to the enumeration of persons who live in institutions as well as persons who were located on the streets and this was taken into account in the design.

The census design also included a Post Enumeration Survey planned as a coverage assessment tool. The Post Enumeration Survey was conducted during

the period September 7-30, 2011 in all parishes and covered a 5 per cent sample of census EDs. A total of 286 EDs were eventually canvassed.

The Institutional Population

All institutions, which could be regarded as the usual residence of the inhabitants either because they had no other residence or because they were 'long-term' residents, were included. General hospitals, public and private were therefore generally excluded. The treatment of the institutional population as regards the questions asked was determined by the accessibility of the persons resident to the interviewer. Where no access was possible, only age and sex data were retrieved from administrative records. Where access was possible, the entire individual questionnaire was administered. Trainees and students of all educational institutions were canvassed with the individual questionnaire.

If an institution contained separate quarters for staff members, caretakers, etc., these quarters were treated as private dwellings.

Types of Institutions

- (i) Convents and Monasteries
- (ii) University and College Residences
- (iii) Hostels and Residences for Trainees and/or Graduate Teachers, Nurses and Ministers of Religion
- (iv) Military Camps, Police Training Schools and Police Barracks
- (v) Boarding Schools and Other Residential Schools
- (vi) Correctional Institutions, Penitentiaries, Prisons, Rehab Centres, Juvenile Institutions
- (vii) Mental Institutions
- (viii) Homes for Children/Aged/Infirm/Needy
- (ix) Hospitals and Homes providing specialized care
- (x) Hospitals and Homes for the Blind, Deaf and Other Handicapped

Persons on the Streets

This group comprises persons who may or may not be usual residents of a private or non-private dwelling. Area Managers were instructed to familiarise themselves with the locations where such persons tend to frequent for purposes of sleeping, and obtain as much information as possible. Locations included bus parks, markets, drains and sidewalks. Some persons were also identified by charity organizations which provide daily meals for such persons.

The Scope of the Census

The United Nations Principles and Recommendations guided all technical considerations including the choice of topics. The topics included on the census questionnaire were as follows:

- Availability and Type of Kitchen, Bathroom and Toilet Facilities
- Method of Disposal of Solid Waste
- Source of Water for Domestic Use,
- Source of Drinking Water
- Type of Lighting
- Type of Fuel used for Cooking
- Availability of Telephone and other Communication Devices and facilities
- Migration and Mortality

Geographic Division of Jamaica for Census Purposes

Jamaica was divided into 5,776 geographic units called enumeration districts (EDs) for the purpose of data collection during the 2011 Population and Housing Census (see Appendix I). Each ED is an independent unit which shares common boundaries with contiguous EDs. The number of dwellings/households contained in the ED (estimated before the census) was the primary determination

of the size of an ED. This was approximately 150 dwellings/households in urban areas and 100 in rural areas. Each ED was designed to be of a size that would ensure an equitable work load for each census taker, and because dwellings are more widely spaced in rural areas than in urban areas, rural EDs usually contained fewer dwellings/households than their urban counterpart. When grouped together, enumeration districts reconstitute larger divisions; special area, constituency and the parish.

Field Organization

For administrative purposes the island was divided into 7 Regions, 62 Coordinator Areas and 1,029 Supervisory Zones. A central Census Office was established in the Kingston Metropolitan Area (KMA). Seven Regional Managers who were selected from STATIN's permanent field supervisors operated from offices in the KMA, Linstead, May Pen, Black River and Montego Bay. Each of the 62 Area Coordinators maintained an office in a central location in the area. The field organization operated under the direction of the Director of Field Services.

Field Enumeration

Field enumeration started slowly on April 5, 2011 as many Census Takers had not been issued identification cards. For an identification card to be issued, the Area Coordinator must have completed the selection process and submit the relevant information to the head office where checks had to be made to verify the training location of the individual. Photographs for identification were stored by training sites so this information had to be retrieved to request the identification from the service providers.

The collection process limped for the first three weeks of April and returns were slow. Census takers began to express dissatisfaction with what they considered late payments of Training Fees. By the beginning of May with such payments made, the pace of enumeration picked up somewhat but census workers again began agitating for payments of claims for travelling even in some instances with very little or no work done. The militancy continued as the problems with these first payments were resolved very close to the pay period. Some persons threatened to leave the job. At this time members of the senior staff of STATIN were kept busy responding to the media as they were approached by dissatisfied census workers.

A number of supervisors and census takers gave up the job while others were relieved because of non-performance but by the time that began to happen, there were persons available as replacements. The data collection phase ended on August 31, 2011.

Challenges of Data Collection

The main challenges encountered could be summarized in the following-

- the general hostility of the population with what was regarded as a 'government' project;
- the inability to relate their participation with immediate personal benefits;
- the belief that the information would be given to the tax collectors;
- violence in some areas and the inability to be out late at nights;
- incidents of dog bites;
- lack of access to gated communities;
- inefficient and unproductive census workers.

Economic Activity in the 2011 Census

Introduction

Economic Activity

The census topic relating to economic characteristics concentrates on the economically active population as defined by the International Labour Organization (ILO) where the concept of economic production is established with respect to the System of National Accounts (SNA).

The *economically active population* comprises all persons, men and women who provide or were available to provide the supply of labour for the production of economic goods and services, as defined by the SNA, during a specified time period.

Activities are within the production boundary defined by the SNA if they comprise the following:

- Production of goods and services supplied or intended to be supplied for sale in the market;
- Own-Account production of all goods retained by their producers;
- Own-Account production of housing services by owner-occupiers and of domestic and personal services produced by paid domestic staff.

Domestic or personal services provided by unpaid household members for final consumption within the same household are not considered economic activities. Examples of this type of activity are housekeeping, care of children, the sick and the elderly.

The economically active population can be measured in different ways and the ILO recommends two ways. One approach uses the *usually active* population measured in relation to a long reference period such as a year and the other uses the *currently active* population or the *labour force* measured in relation to a short reference period such as one week. Two main advantages of using the short reference period are recognized. In the first place this minimizes the possibility for recall errors. Secondly, the short period limits the possibility of having a large number of different activities being undertaken, that would probably be more likely over the longer period. A minimum age for the target population should also be established.

The United Nations recommends that whatever the period of emphasis, supplementary data should be collected for the alternate period. The focus of the modern Jamaican censuses has always been the current activity with most of the

questions on economic activity focused on this concept. These questions are supplemented by one question related to the usual economic activity.

For census 2011, the reference week for measurement of the currently active population was the last week of March 2011 while the reference period for the usually active was the 12 months preceding Census Day, April 4, 2011. The minimum age was 14 years.

When classifying the population by activity status, precedence is given to being economically active; in other words a student who was looking for work would be classified as looking for work rather than as a student. A retired person who was working would be classified as being employed. Probing is especially important for persons and women in particular who are doing house work most of the time but who might have been engaged in economic activity during the reference period.

The Concept of Work

The concept of *work* is basic to the understanding and interpretation of statistics on economic activity.

Work includes:

1. Work with pay
2. Work without pay

Work with Pay

- Work for others (government, business organization or individual) for a wage or salary including commission or tips;
- Work as a trainee or apprentice;
- Work for self in one's own business (including a farm) which is run for profit or fees and may or may not employ paid help.

Work without Pay

- Work without pay in a business or farm run for profit (usually by a relative) in cases where the individual is either supported by the owner or obtains some benefits other than cash from the running of the business;
- Work as an unpaid helper in a business or other organization, in cases where the respondent is learning a trade or profession with a view to be engaging in work for pay.

The following cases are not considered work:

- Work without money or pay for a relative or other person at tasks which did not contribute to the operation of a farm or of a business, for example housework, gardening, odd jobs around the house or yard;
- Work without pay assisting a relative or friend in his/her duties as an employee;
- Work without pay either in cash or in kind as a volunteer worker for a service for example with the Society for the Blind etc.

Work was related to work in Jamaica. Farm workers and other overseas contract workers were therefore excluded. Included however were the activities of persons resident in Jamaica but who operated on airplanes, ships etc. Travelling sales persons, consultants and Informal Commercial Importers were also included.

Consistency with the Labour Force Surveys

The concepts and definitions used for economic activity in the census are consistent with those used in the regular Annual Labour Force Sample Surveys designed to capture current economic activity. Quarterly Labour Force Surveys are conducted with reference weeks as the last full week of March, June, September and December each year. As is the practice during a census year, no survey was done around the time of the census. For 2011 the March survey was therefore not conducted.

It is very important to note that in general the census numbers will differ from those produced by the Labour Force Survey. Coverage for the survey is restricted to private households only while the census covers private households as well as a small number of institutions. The survey is specifically designed to capture information on the labour force and its components and therefore asks a more detailed and extensive series of questions than can be covered in the census. The census is the only source of this type of data for many countries and is especially useful because the data are produced at the small geographic level.

Explanation of Categories

Currently Active/The Labour Force

This relates to all persons, classified as employed and unemployed during the last week of March 2011.

Usually Active

This relates to all persons, classified as employed and unemployed during the twelve months ending April 3, 2011.

Employed

This relates to all persons who worked *for at least one hour*, during the reference period, according to the definition of work given. Persons who had a job but were temporarily absent due to illness, vacation leave, strike or lockout or lay-off of not more than 30 days duration, were classified as 'worked'. The one hour criterion is an essential feature of the labour-force framework embedded in the international definitions of employment and unemployment, and a prerequisite of the consistency of employment statistics with national accounts data on production.

Unemployed

Included are persons who did no work during the reference period and who were interested in working. Some of these persons would have been *seekers*, actively engaged in looking for work, by writing applications, answering newspaper advertisements and or visiting worksites. Others, *non-seekers*, would not have been actively seeking work but wanted work, were available for work and would have taken a job if offered.

Inactive

These are persons who were neither employed nor unemployed according to the definitions outlined. The inactive population comprises the following groups:

Students

Full-time students in primary, secondary, technical or other schools, at university or engaged in private studies. Students on holidays were included.

Home Duties

Persons, who had no jobs, were not seeking work and who were engaged in looking after their own homes, that is, cooking, washing, cleaning etc. It does not cover domestic servants and others who were performing these duties in other people's homes for pay, as these would be classified as having worked.

Retired, Did Not Work

Persons who previously worked but who were retired and who during the reference period were not working or seeking work.

Disabled, Unable to Work

This covers persons who were unable to work because of some physical or mental disability. This category is likely to include cases of temporary disability.

Not Interested in Work

This covers persons who were not engaged in any of the activities previously outlined and indicated a lack of interest in working.

Other

This group includes all persons who reported vague answers and who could not be assigned into any of the categories.

Section 5 of the Individual Questionnaire shown at Appendix III shows the questions relevant to Economic Activity. The first four (4) of the twelve (12) questions were designed to establish the current activity status of the individual. Persons identified as economically active on the basis of their responses to these first four were then asked questions relevant to their current and or past employment, such as occupation, industry and employment status.

QUESTIONS WERE ASKED OF PERSONS 14 YEARS AND OVER ONLY.

Findings from the Census

Table (i) presents the main indicators of economic activity from Census 2011. The table shows that approximately 57 per cent of persons of age 14 years and over were economically active in the week preceding the census. Of the approximately 1.158 million persons classified as such, just under 1 million (995,724) were employed. The resulting employment rate was 86 per cent and the unemployment rate, 14 per cent. Men were more likely than women to participate in economic activity with a participation rate of 67 per cent compared to the 48 per cent for women. Participation Rates by age groups show that participation was highest (73 per cent) for the 20-44 years age group followed by the 45-64 years old (67 per cent). The data on median ages show the median age of the labour force to be 37 years, two years older than the age of the eligible persons of 14 years and over. The Employed labour force was 12 years older than the unemployed with a median age of 38 years compared to 26 years.

The rates of employment and unemployment presented show that despite the differentials with respect to participation rates for men and women there was no difference in rates of employment (86 per cent) and unemployment (14 per cent) between the sexes. Employment rates increased with age, being lowest (47 per cent) among the youngest, persons under 20 years old and highest (96 per cent) for the oldest, persons of age 65 years and older. Conversely, the likelihood of

being unemployed declined with increasing age. More than one half of the labour force of ages under 20 years (53 per cent) was unemployed. The rate dropped to 15 per cent for the population 20-44 years old, to 6 per cent for the 45-64 years old and by age 65 years and over had fallen to 4 per cent.

The geographic distribution of the labour force (table (ii)) follows the distribution of the population 14 years and over very closely with about 70 per cent of the labour force living in the six largest parishes of St Andrew (22 per cent) St Catherine (19 per cent), Clarendon (9 per cent), Manchester (7 per cent), St James (7 per cent) and St Ann (6 per cent).

The labour force participation rate was highest for St James (61 per cent) followed by St Andrew (60 per cent) and Kingston and St Catherine (59 per cent). The parish with the lowest participation rate was Clarendon (51 per cent) followed by St Thomas, St Elizabeth, St Mary and Portland (52 per cent).

The parishes of Kingston, Hanover and St Ann showed the highest unemployment rate of 16 per cent, while parishes with unemployment rates below the national rate of 14 per cent were St Andrew, St Elizabeth and Trelawny (13 per cent).

The Employed Population

Employment Status/Occupation/Industry

Individuals can be classified according to employment status, occupation and industry through their relationship with a job. These topics are accordingly only relevant to the economically active population. These questions must relate to the same job. Questions on employment status in the 2011 census were asked only of persons currently employed. Questions on occupation and industry were relevant to persons currently employed *as well as those currently unemployed who had worked previously*. Where more than one job was held, the one considered was that which the person regarded as the main one, either because it provided the greater income or because more time was spent performing it.

Employment Status which is also referred to as Status in Employment relates to the status of the person with respect to his/her employment, which is the contract of employment with other persons or organizations. Table (iii) presents the percentage distribution of the employed population which responded to this question, by employment status separately for each sex. The majority (46 per cent) of employed persons reporting were classified as paid employees in private enterprise. The second highest category of workers (29 per cent) was classified as self employed persons without paid employees. These persons are also referred to as own-account workers. Paid government employees accounted for 15 per cent of the total employed reporting.

The likelihood of being a paid employee in private enterprise was slightly greater for men than women. The percentage of the employed male reporting as paid employees of private enterprise was 46 per cent compared to 45 per cent for

females. Men (34 per cent) were much more likely than women (21 per cent) to be self employed without paid employees. On the other hand the likelihood of being employed by the government was far greater for women than for men. While 20 per cent of the females reporting status in employment were paid government employees, the comparable percentage for men was 10 per cent. As expected the percentage of women employed in private households (9 per cent) far exceeded the percentage of men (1 per cent).

Industry refers to the activity of the establishment in which an employed person worked during the reference period, or last worked, if unemployed. The industrial classification for 2011 was based on the Jamaica Industrial Classification (JIC) 2005, which is based on the International Standard Industrial Classification (ISIC) Rev3.

Employment in Industry is the subject of table (iv) which presents the percentage distribution of the employed population by sex, in eleven major industry groups. At census 2011 the major industry group which accounted for the largest share (20 per cent) of the employed population covered, was the group, Wholesale and Retail, Repair of Motor Vehicles and Personal and Household Goods. Agriculture, Forestry, Fishing, Mining and Quarrying followed with 15 per cent and Education, Health and Social Work with 10 per cent.

Five of the eleven groups were female dominated and five were male dominated. The industry group with the highest percentage of women compared to men was, as expected Private Households (85 per cent). The others were Education, Health and Social Work (78 per cent), Hotels and Restaurants (59 per cent), Other Community, Social and Personal Service Activities (57 per cent) and Financial Intermediation, Real Estate, Renting and Business Activities (51 per cent). The male dominated groups were in the first place those generally referred to as "hard hat" - Construction (96 per cent), Transport, Storage, Communications and Public Utilities (80 per cent), Manufacturing (70 per cent) as well as Agriculture, Forestry, Fishing, Mining and Quarrying (83 per cent) and Public Administration and Defence, Compulsory Social Security and Extra Territorial Organizations (55 per cent). The group Employment in Wholesale and Retail, Repair of Motor Vehicles and Personal and Household Goods was equally divided between men and women.

Occupation refers to the type of work done during the reference period by the person employed or the type of work done previously, if the person was unemployed. Occupations were coded based on The Jamaica Standard Occupational Classification 2011 (JSOC 2011) which is based on the International Standard Classification of Occupations (ISCO-2008) prepared by the International Labour Organization (ILO) and released in 2008. At the time of the 2011 census, the JSOC was still in the early stages of development. The ISCO structure identifies five levels as follows: Major Group (example Professionals), Sub-Major Group (example Health Professionals), Minor Group (example Medical Doctor), Unit Group (example Specialist Medical Practitioner) and Occupation (example Surgeon). Due to the stage of development at the time of the census, coding in many cases was restricted to the sub-major or minor group. The results are presented at the major group level and in some instances groups are combined.

The data on occupation groups are presented in table (v). Eight groups are identified. The largest percentage of the employed population (26 per cent) was engaged as Service and Sales Workers. The second highest (15 per cent) was engaged as Skilled Agricultural, Forestry and Fishery Workers. Craft and Related Trades Workers, Managers and Professionals and Elementary Occupations each accounted for 14 per cent of employed workers. The data presenting the sex distribution shows that women were three times as likely as men to be Clerical Support Workers as 75 per cent of these workers were women. Other occupation groups dominated by females were Service and Sales Workers and Managers and Professionals (62 per cent). Just over one half (52 per cent) of the workers in Elementary Occupations were women. Elementary Occupations include domestics and unskilled general labourers. Occupation groups which were overwhelmingly male were Plant and Machine Operators and Assemblers (94 per cent), Craft and Related Trades (90 per cent) and Skilled Agricultural, Forestry and Fishery (85 per cent). The group Technicians and Associate Professionals had only slightly more males (51 per cent) than females (49 per cent).

Hours Worked

In the census, hours worked referred to the actual time worked, and the question was applicable only to persons who were on the job. For persons who had more than one job, the time related to that job which the person regarded as the main job. Table (vi) which is based on employed persons, shows that more than a half (56 per cent) of persons reporting worked between 25 and 40 hours during the reference week.

Table (vii) shows the average number of hours worked during the reference week by employment status. The overall average number of hours worked during the week was 40 hours. The highest average (43 hours) is seen for the self employed with paid employees and the lowest, if unpaid workers are not considered, is seen for workers in private households who worked on average 36 hours during the reference week.

The Unemployed Population

The unemployed comprises job-seekers and non-seekers during the reference period. As described previously, job-seekers were persons who were actively engaged in looking for work. Non-seekers were persons who wanted and were available for work although not actively seeking.

Census 2011 counted 162,472 persons 14 years old and over who were classified as unemployed (table (viii)). As the table shows, about 9 out of every 10 of these persons were actively looking for work. A slightly higher percentage of the female population (94 per cent) compared to 93 per cent of males were classified as job-seekers. With respect to age, the percentage decreased with age from 96 percent of the population of ages under 20 years to 82 per cent for the oldest, the 65 years and over. The national job seeking rate which is calculated as the percentage of job seekers in the total labour force was 13 per cent. The rate for the under 20 years age group was an extremely high 51 per cent. This means that over a half of the population of this age group in the labour force were actively looking for work.

The parish distribution of the job seeking rate which is presented in table (ix) follows the pattern of the unemployment rate with the highest rates being observed for Kingston, Hanover and St Ann (15 per cent). St Andrew, St Elizabeth, Trelawny and St Thomas had the lowest rates, 12 per cent.

Questions on Occupation and Industry were asked of unemployed persons who had worked previously. Table (x) presents the data for unemployed persons on the last occupation held. Six of every ten of the currently employed population were last employed in Construction (24 per cent), Wholesale and Retail, Repair of Motor Vehicles and Personal and Household Goods (20 per cent) and Hotels and Restaurants (16 per cent). Only 2 per cent of the unemployed had last worked in Public Administration and Defence, Compulsory Social Security and Extra Territorial Organizations.

The Currently Inactive

As indicated previously, economic inactivity reflects total non-participation in any form of economic activity. The categories identified for these persons were students, home duties, retired, disabled and not engaged in work of any form or not seeking work. Included also was a category 'not interested' and a category 'other' which reflects vague responses. Table (xii) shows that about three quarters of the inactive population were split between home duties (40 per cent) and going to school (35 per cent). Approximately 16 per cent were retired persons who were not engaged in any economic activity.

The sex distribution shows that students (53 per cent), persons keeping house (80 per cent) and retired persons (54 per cent) were more likely to be female than male. On the other hand, the inactive population classified as 'Not interested in Work' was more than twice as likely to be men (69 per cent) than women (31 per cent).

Usual Activity

As defined previously, usual activity refers to economic activity over a longer period than the current activity. It refers to the main activity in the twelve month period before the census. The main activity was defined as that in which the person was involved most of the time (for six months or more), in Jamaica. Any activity outside of the country was not considered.

Table (xiii) shows that over the longer period the overall unemployment rate (16 per cent) was higher than the 14 per cent observed for the reference week. A similar pattern is observed for men and women and for all age groups. What is observed also is that over the longer reference period the unemployment rate for women (15 per cent) was lower by one percentage point than for the men.

Social Welfare

For census 2011 two questions on social welfare benefits were asked of the population 60 years old and over. The categories identified were as follows: Employment Related Pension, National Insurance (NIS), Programme of Advancement through Health and Education (PATH) and other Public Assistance or Poor Relief. Employment Related Pension includes pensions from overseas employment. National Insurance refers to the (Jamaican) compulsory contributory funded social security scheme which offers financial protection to workers and their families against loss of income arising from injury on the job, incapacity, retirement and death of the insured. The PATH programme for Jamaica provides benefits by way of cash grants to specific groups, identified as vulnerable, such as children, the elderly and pregnant and lactating mothers. Other Public Assistance comes in the form of Rehabilitation Grants, Compassionate and Emergency Grants and Education and Social Intervention Grants. There are restrictions in accessing benefits from PATH and Public Assistance at the same time.

The treatment of PATH beneficiaries for this question requires some clarification. Ideally this should have been a household question, scored 'yes' for any household which included one or more beneficiaries. It was inadvertently placed on the individual questionnaire. Persons were therefore recorded as 'yes' once someone in the household was a recipient. The assumption is that in some indirect way all household members benefit.

It is fairly common in data collections for persons to show some amount of reluctance in answering questions which ask about monetary benefits, much like income. The data should therefore be interpreted with the understanding that there could be some under-reporting.

The question allowed for multiple answers so persons reporting Employment Related Pension may also report National Insurance. Table (xiv) below does not take account of the multiple answers but reflects the persons indicating that they receive benefits from the particular source.

Less than one-half (46 per cent) of the population 60 years and over, numbering about 138,000 persons, reported being in receipt of at least one of the benefit types. The majority of persons receiving, more than a third (37 per cent) were benefiting from the PATH Programme, 31 per cent from National Insurance and 27 per cent from Employment Related Pension.

The percentage distribution of the total of each benefit type for each sex shows that almost as many men as women 60 years old and over were in receipt of an Employment Related Pension at the time of the census. For all other sources, the percentage of women exceeded the percentage of men. Sixty per cent of the

population 60 years old and over on the PATH Programme were women, 58 per cent receiving NIS and 61 per cent in receipt of Other Public Assistance, were women.
